# MH370, 4 years on: Malaysia says search to end in June

A MALAYSIAN official said yesterday that the search for Malaysia Airlines Flight 370 by a US company will likely end in June, as families of passengers marked the fourth anniversary of the plane's disappearance with renewed hope that the world's biggest aviation mystery will be solved.

Malaysia inked a "no cure, no fee" deal with Houston, Texas-based *Ocean Infinity* in January to resume the hunt for the plane, a year after the official search in the southern Indian Ocean by Malaysia, Australia and China was called off.

*Ocean Infinity* started the search on January 22 and has 90 search days to look for

the plane. Malaysia's civil aviation chief, Azharuddin Abdul Rahman, said the 90-day term will spread over a few months because the search vessel has to refuel in Australia and bad weather could be a factor.

Azharuddin said the search is going smoothly and is expected to end by mid-June.

"The whole world, including the next of kin, have (new) hope to find the plane for closure," he told reporters at a remembrance event at a shopping mall near Kuala Lumpur.

"For the aviation world, we want to know what exactly happened to the plane."

Officials have said there was an 85 per cent chance of finding the debris in a new 25,000-square-kilometre (9,650-square-mile) search area—roughly the size of Vermont—identified by experts.

If the mission is successful within three

months, payment will be made based on the size of the area searched. Malaysia says it will pay *Ocean Infinity* US\$20 million for 5,000 square kilometres (1,930 square miles) of a successful search, US\$30 million for 15,000 square kilometres (5,790 square miles), US\$50 million for 25,000 square kilometres (9,653 square miles) and US\$70 million if the plane or flight recorders are found beyond the identified area.

The plane vanished March 8, 2014, while flying from Kuala Lumpur to Beijing with 239 people on board.

The official search was extremely difficult because no transmissions were received from the aircraft after its first 38 minutes of flight. Systems designed to automatically transmit the flight's position failed to work after this point, according to a final report issued in January 2017 by the Aus-

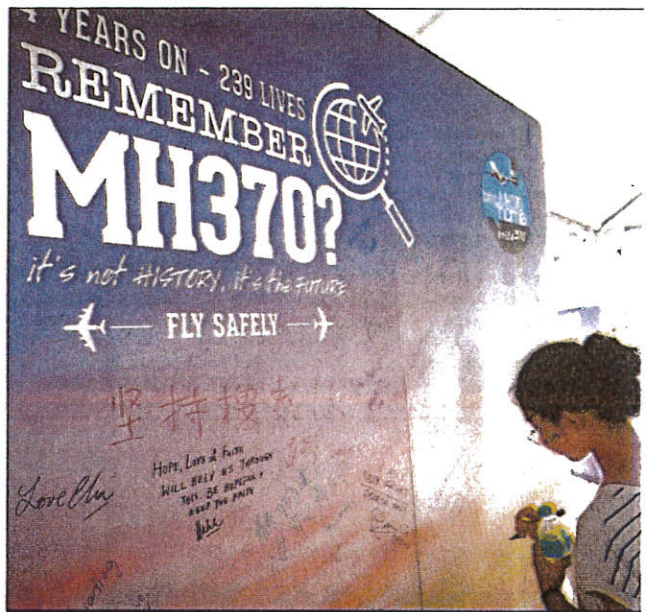
tralian Transport Safety Board.

Family members lit candles on a stage yesterday and observed a moment of silence during the three-hour event. Most are split over whether the search will be fruitful.

"It doesn't renew (any hope) because I also have to be realistic. It has been four years," said Intan Maizura Othman, whose husband was a flight attendant on the plane. She was pregnant when the plane disappeared and attended the event with her now four-year-old son.

Jiang Hui of China, whose mother was on board the plane, said that he was grateful for *Ocean Infinity's* courage to mount the search, but that he hopes it will not be the end if the mission fails. He proposed for a public fund to be set up to continue the search.

"Without a search, there will be no truth," Jiang said.

## SANTA FE Invasive plant threatens wetlands

AN INVASIVE plant from central Asia and southern Russia is sucking wetlands in northern New Mexico dry and officials in the area want to see the tree gone.

Officials from the Santa Fe Botanical Garden recently removed 6.5 acres (.02 square kilometres) of Russian olive trees from the Leonora Curtin Wetland Preserve as part of a long-term preservation effort, the *Santa Fe New Mexican* reported.

"Our biggest intent with tackling the Russian olive is to keep the ciénega (wetlands) wet," said Botanical Garden director of Horticulture Scott Canning.

"When they leap out in the spring, the water table drops four feet," he added, noting the trees "are notorious for removing water from the ground".

Russian olives are also a problem in the Santa Fe National Forest. The trees grow in midrange elevations, including along the Jemez River, where they compete for water with native trees.

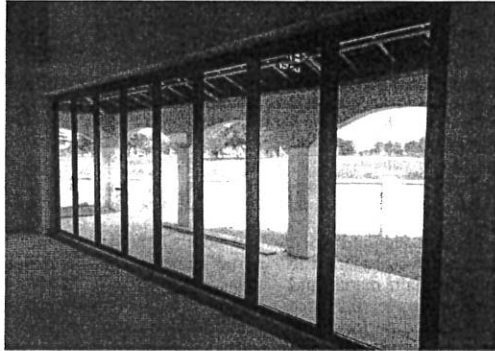

# Windies focussed on World Cup qualification says Miller

HARARE, Zimbabwe - Nikita Miller said getting to the 2019 ICC Cricket World Cup in England and Wales was the main objective of West Indies above anything else.

The left-arm spinner was speaking following his destructive spell against the United Arab Emirates earned the Windies a 32-run victory on Thursday in their final warm-up match ahead of the start of the ICC World Cup qualifiers.

"The main goal is to get to the World Cup," he said. "We need to apply ourselves and get fully ready for that opening match (on Tuesday).

"We have some very experienced players who have played a lot of international cricket and have seen many situations in the game, so we will be ready for whatever is thrown at us. "We will have play to our strengths and draw on our experience. I made my debut 10 years ago and I have played a lot of cricket. I'm not thinking about myself, but I'm thinking about the team in every situation."

Miller warmed up with a spell of 5-20 from his allotted 10 overs, as the UAE were dismissed for 83, after Windies were bowled out 115 on a surface offering generous turn to the slow bowlers.

"It was a good day for me," he said. "I got five wickets at a crucial stage in the match and did what was required by the team."

"That's what it's all about for me - doing what the team needs to win. I'm all about doing the job. It was very important for us to get some solid cricket under our belts as we prepare for the tournament."

He added, "We didn't go so well in the first warm-up match against Afghanistan, which didn't go according to plan, so we had to get things together."

"Even though we didn't get enough runs, our bowling display was excellent

and congrats must go to all the bowlers for putting in a very good performance, especially Kemar Roach in the early part of their innings. I think the bowling display was very good."

Jason Holder's side face the same opponents on Tuesday in the opening match of the competition at the Old Hararians.
